## Minutes Emerson Unitarian Universalist Church Annual Congregational Budget Meeting Sunday, December 12, 2011

The meeting was called to order at 12:16 pm by President Sarah Boyd. It was determined that a quorum was present. Becky Edmiston-Lange gave an invocation. Copies of the budget were made available to those in attendance.

Sarah reviewed the process by which the current budget was prepared. Planned contributions, which constitute the largest share of our income, dropped from 71% in 2011 to 67% projected for 2012. In part this reflects the impact of the 10% Solution for the Social Action grants, but nevertheless there was a real decline in pledging. The main features of the 2012 budget are 1) no raises or new hires, 2) supplemental fundraisers to bring in an additional \$32,000, 3) an increase in expected special collections, primarily for Social Action projects, and 4) reduced transfer from the Endowment to fund the new DRE position.

On the expense side professional expenses, the Worship Committee, Committee on Ministry, Communications Committee, Caring Committee, Adult Education and covenant groups were all reduced. The DRE salary is less than in 2011 because of the changeover from Barbara Stoddard to Katy Carpman. The Leap of Faith initiative is concluded and its functions will be assumed by other groups. SAC was reduced to \$1000 from \$4000 to be in line with our policy manual regarding SAC funding. The current policy states that SAC funds are to be used for operations and seed money to Emerson task forces and not for donations to non-profits. Sarah also noted that the UUSC line item should be grouped with other denominational expenditures as was pointed out last week by deForest Ralph. The office expects that we can reduce our electrical consumption somewhat but water use may continue to be a problem if the drought persists.

Sarah recognized Stewardship chair Richard Loftin who detailed the results of the canvass drive. He said the church lost one \$50,000 pledge that should have been considered a one-time gift. Several other members had to reduce their pledges due to the weak economy; we had 22% in decreases this year compared with 14% last year. In contrast a number of members increased their pledges, helping to offset the \$50,000 loss. The total now stands at \$512,000 with 12 pledges outstanding; Richard expects the final sum to be around \$525,000. Stewardship is considering several ideas for supplemental fundraisers including a big trash pick-up project (so much per pound), a golf tournament, a Valentine's Day Sweetheart Dance, and perhaps a second auction.

As a point of information Sarah briefly described Will Irwin's work on a revision of SAC's 10% Solution in which a percentage of the corpus rather than the market gain of the Endowment would be devoted to SAC projects. Citing increased support in the congregation for social action, he believes that changing to this formula would provide a steadier income stream.

Sarah then asked for a motion on the budget. Eric Watson **moved** that the proposed 2012 budget be accepted and Richard Loftin **seconded.** The floor was then opened to discussion. deForest Ralph cited the lack of membership growth and attendance at services and said we need "an explicit intention" for growth. He said that Susan Smith, SWUUC <u>Director</u>, <u>said in 2007</u> that the Bay Area UU congregation was the only one in the Houston area that is growing, and he believes it is because of their emphasis on covenant groups.

Barbara Crotty asked for a clarification on the DRE salary, which Sarah and Vice President Beth Hill explained is based on UUA guidelines that take experience into account. Ben Withers asked how much it would take to bring our salaries up to "fair compensation" level; Finance chair Tony Collins said it would take about \$50,000 overall. deForest said that our compensation is generous for our area, though others disagreed. Membership chair Eric Watson thanked deForest for his comments on increasing membership and said his committee is working on that. Jack Shada asked about cutting personnel costs.

SAC co-chair Phil Richardson noted that pledges have been essentially flat for 10 years, and that the last time we had a surplus without an Endowment transfer was in 2008. On behalf of SAC he objected to cutting their line item expense from \$4000 to \$1000, citing the results of the recent SAC survey. He stressed that the operating budget is different from the 10% Solution money and that raised by special collections, which are designated for specific projects. Phil proposed an **amendment** that would restore SAC's line item to \$4000, to be paid for by a 15% reduction in expense accounts and the funding for both the Stewardship Dinner and the Leadership School. Susan Raffle **seconded** the amendment. Bonnie

Homier pointed out that the SAC operating budget is to be used for start-ups and that she feels that SAC needs to publicize their efforts more. Tony said that SAC's request was for \$10,000 which was cut to \$4000 by the Finance Committee. That sum included \$2000 for ongoing commitments, mainly the international scholarships through the UUA. The Committee had already cut discretionary spending by 10%, and the Board cut SAC further to \$1000. Gabe Gelb reminded the congregation of our statement of purpose, which includes the phrase "to build a better world." He said that SAC is our public face to the outside community as well as to our own visitors.

Sherle Frost Watson, Board member and Communications chair, said that the Communications Committee requested \$7400, which was reduced to \$2000. Although the expense of the NPR ads is gone, the Committee had other avenues of publicity in mind, especially an increased use of social media. The reduced level of funding will make that difficult if not impossible. She added that this kind of publicity is what brings people in the door.

David May said that Phil's amendment, by reducing professional expenses, goes against Emerson's Bylaws, which state that the terms of employment are to be set by the Board of Trustees. Betsy Gelb, serving as parliamentarian, said she had anticipated this point and consulted an employment lawyer; she agreed with David. David said that SAC is receiving other funds ten times the amount under dispute, and referred to previous years in which some members objected to any funding of social action through the operating budget. Attitudes have changed since then, but David said he is opposed to increasing the deficit to restore SAC's \$4000. Will Irwin pointed out that the 10% Solution money does not go to SAC. SAC chooses the recipients of that fund, which have to be agreed to by both the Board and the congregation. He also opposed Phil's amendment, and said he would add \$3000 to the deficit instead.

Richard Loftin said that Stewardship is willing to accept a decrease of \$4000 to be split equally between Communications and SAC. He said that a number of expenses of this year's canvass were privately donated and that alternative sources could be found again. Carole Huelbig **called the question** on Phil's amendment, which **did not pass.** Richard then proposed an **amendment** that Stewardship's budget, now at \$6000, be reduced by \$4000, with \$2000 each going to Communications and SAC. Carole **seconded.** After a brief discussion, David **called the question** on Richard's amendment, which **passed with one opposed.** Discussion then returned to the original motion as amended. There was some talk for and against referring the budget back to the Finance Committee. Board member Wilson Arabie remarked that it is hard to "make the numbers fit," and that we need further contributions and fundraisers. He added that we need to keep members as well as bring in new ones. Ken Salzman expressed some confusion over the sources for SAC's funding. Tony spoke to the need to have all sources reflected in the financial statement for transparency. He added that the church leadership has to generate a fall-back position to balance the budget if membership numbers don't improve. There being no more discussion, Sarah called for the vote on the motion as amended. It **passed with two opposed.** The congregation applauded Sarah's leadership and hard work on the budget issue.

## **2011 Annual Report - Co-Ministers** Becky and Mark Edmiston-Lange

This Sunday after church services were over there were four separate meetings going on: Communications Committee; Social Action Council; Southwest Conference Annual Meeting Planning Committee; and Introduction to Unitarian Universalism. It is not unusual to find 15 to 20 (or as on this past Sunday over 30) members of the congregation engaged in planning and decision making to accomplish the goals of the congregation. Emerson is a very busy place and your ministers are also very busy keeping up, cheerleading and advising.

Of course, you most routinely see us conducting worship on Sunday morning. That hour is central to what we do as your ministers. Preparation for worship and coordinating all the moving parts that go into the worship service make up the largest parts of our concentrated effort. We intend with that hour to provide timely information from a Unitarian Universalist perspective that helps us all make sense of our lives, celebrate our joys, mourn our loses, and chart a positive pathway ahead.

Yet much of what we do as ministers is not that obvious. After all, what do any of us know of another's profession unless we perform the services of that profession ourselves? It is easy enough to imagine that we provide counseling to members of the congregation. Less visible is the fact that, for instance, we meet with every committee where it is possible for us to do so. Since many committees now meet at the same time, as with this past Sunday, we will miss some. Some are surprised at the amount of time we devote to these meetings but we regard ourselves as church program consultants and seek to augment Emerson's very impressive lay leadership with our wide ranging experience. We do know a lot about churches, about Unitarian Universalism, and about the wider resources available to Emerson from the Unitarian Universalist Association. We never seek to trump what lay leaders know – only augment with suggestions about what we think might be productive avenues to pursue. As mentioned above, the level of leadership by volunteers in the congregation is simply outstanding.

Every year, in conversation with Board of Trustees, we also select several emphases for our ministry which we believe are important to Emerson's overall success as a congregation. This past year our first goal was working with the DRE search committee to bring an outstanding candidate to Emerson as our new Director of Religious Education. In addition, once that selection was made, we felt it was also important to support the start up and integration of that new director into the life of Emerson.

We feel that the Search Committee hit a home run. Years of preparation and planning do not always pay off – this time they did. We are also very pleased with how well Katy Carpman has stepped into her role and we believe the program will continue to thrive and grow as she utilizes her talents to support the great leadership of the Religious Education Committee and teaching staff.

Our second goal was supporting the Leap of Faith Team in their efforts to provide suggestions for Emerson's capacity to attract and integrate new members of the congregation. The Team's work has been outstanding and we would like to especially thank Linda Condit, Mark Andersen, Holly Gilliland, Sarah Boyd, Nancy Lipp and Ben Withers for their work on this team. Many of the suggestions the team have made, such as the development of Building Your Own Theology course, have already been implemented. The road map the team has outlined for the future of Emerson has a great deal of promise. The continued development of the Membership Committee is an important component of that road map. Another element which has already been implemented is the "Join Emerson Sunday" in which the benefits and obligations of being a member are explained to individuals on one Sunday a month after church.

In addition, it was time this past year to train new members of the Lay Pastoral Ministry Team. The training was held last spring and resulted in three new Lay Pastoral Ministers. (We also trained 5 individuals from the Northwoods UU Church who wanted to start this program in their own church.) LPMT continues to be a very important part of Emerson's life as a congregation.

A fourth goal was working with our new Music Director Bonnie Wellington in building up and integrating the performing arts program at Emerson. With Bill Atkerson's first year as the paid Director of the Intergenerational Orchestra, as well as the development of the Emerson Players, the congregation now has a very full performing arts calendar. It is very

important to us that each of the parts view itself as one element of a larger whole, Emerson Church; and that the demands of each element of such a busy schedule complement one another. One thing is certain; we are in desperate need of more volunteers with the Audio Visual Team. The occasions when we need assistance with sound production has increased dramatically – more than the current volunteers can meet without putting their marriages or jobs in jeopardy!

The fifth goal was continuing our efforts on behalf of Social Action at Emerson and in the wider community. Emerson's profile in the community continues to grow because of steady and persistent efforts by the leadership and members of the Emerson congregation. So, for example, Mark was interviewed by Channel 11 news because they felt that the Emerson congregation was a reliable source for commentary. Becky led the invocation at this year's Crop Walk because, once again, Emerson's level of participation was outstanding. (Emerson provides 10-15% of the walkers for the entire city).

A new year stretches out before us. We have goals for this coming year as well (working with the Membership, Adult Education and Spring Conference Committees as well as the Social Action Council to support these important elements of Emerson's life. In addition we will be working with the Board of Trustees in developing a plan for a capital campaign to address several of our pressing capital needs. There are other emphases, such as the Coordinating Council's task force on Governance, which we believe will also create important additives for Emerson's effectiveness at meeting our statement of identity and purpose: to be the beloved community of faith, reason, and affection that welcomes all to grow in mind and spirit was we build a better world.

We want to thank the fantastic staff at Emerson. They are all gems and the congregation derives great benefit from the services of such energetic and talented people. And finally, we are also very grateful for the many lay leaders who make Emerson the vigorous congregation that we so enjoy. The Board of Trustees is simply outstanding – and our President, Sarah Stoffer Boyd – what a delight.

## 2011 Annual Report - President's Report to the Congregation Sarah Stoffer Boyd

2011 has been a busy year at Emerson and the Board of Trustees has worked to advance the goals of the church. I have also written to the congregation each month in order to communicate on a regular basis what the Emerson events, issues, problems and achievements are.

Katy Carpman joined our staff in August as Director of Religious Education and is bringing her skillful leadership to our youth and children, and creating a compelling program for them. Thank you to an excellent Search Committee, chaired by Kim Coolidge, for its hard work and successful conclusion. In November, Jennifer Nichols of the SWUUC District Office conducted a welcoming workshop for Katy where we laid out the background and the goals for our RE program. Jennifer led the attendees through exercises to learn what our UU youth look like, what the needs of our RE director are and what our challenges are.

Work continued on the Leap of Faith (LoF) project with the goal of growth in membership. Emerson was invited to join as one of eight aspiring congregations in the country. This UUA initiative, started in October of 2010, partnered Emerson with Cedar Lane UU Church in Bethesda MD. We exchanged visits and learned how to increase our explicitness around our faith. The LoF team has reported to the Board of Trustees, recommending three areas for change; adopting the AIMS format in congregational activities, changes in the governance structure of our committees, and the hiring of a part time membership coordinator and a part-time RE assistant in the next 3-5 years. The Leap of Faith (LoF) team accumulated many ideas for change during our partnership with Cedar Lane Church in Bethesda. Most of the ideas are incremental changes that can help us be more explicit in our faith. These ideas have been turned over to relevant committees, many of which have already begun implementing them. In addition, all reports are posted on the Emerson Web site.

The 2011 Jungle Safari Service Auction was a great success thanks to the leadership of Nancy Lipp and our volunteers. The auction also raised funds through a Fund A Need auction item to improve accessibility in our sanctuary. The pews

were cut down in four places to make room for wheelchairs and walkers, the carpet and molding was replaced, and soon, handrails will be installed leading to the chancel.

The Endowment Fund increase provided over \$45,000 for grants to qualified organizations through the 10% solution. These grants will provide much needed support to several non-profits in the Houston area. The awards are to be voted on at our annual meeting. Thank you to the awards evaluation team for their hard work at choosing the organizations that best reflect our UU values.

The board of trustees met in retreat four times, completing work on the long-range plan to be voted on at the annual congregational meeting. The May retreat was a special open meeting with Susan Smith. Susan brought the concept of taking the "balcony view" to Emerson and encouraged us to become more visible and to be more representative of the Houston community and its demographics. At the October retreat, the board outlined their goals for 2012. These include supporting the committees, the Leap of Faith recommendations, and also studying the use of the endowment fund, developing a process for handling the balloon payment in June of 2014, and analyzing the needs of Emerson and their costs.

This fall, Karen Van Horn, Larry Huelbig, Larry Kelly and I met with our Frost Bank representatives and discussed our ongoing relationship. There is every indication that Emerson will be in good shape to refinance if necessary. Treasurer Billye Smith and Assistant Treasurer Liz Gammel and Karen Van Horn have created new reporting forms that will facilitate this as well.

The 2011 budget called for a planned use of \$35,000 from the endowment for our new professional DRE. The year 2011 ended with a small surplus that will be rolled in the 2012 operations. New member contributions came in at 116% of planned, while planned contributions fell short at 95%. The summer time cash flow loan from the endowment has been repaid. On the expense side, the facilities costs were high due to the heat and drought. Several trees had to be removed and the sprinkler system repaired. Our total account balances, including the endowment funds, increased \$114,221 in 2011. The annual budget meeting was held on December 11, 2011. Billye Smith prepared the budget presentation and it should be noted that the budget is not balanced. The deficit will be addressed with increased fund raising, cost containment and increased income from leasing if possible.

Thank you to Janet Meininger, Past President and Beth Hill, Vice President for their support this year. Janet has been my mentor and advisor. Beth has led the Coordinating Council and although her job does not permit her to be our next president, I feel certain that her leadership will continue to serve Emerson well. I also want to thank outgoing trustees Janet Meininger and Robin Sickles for their contributions and service. My fellow trustees are all outstanding Emersonians and dedicated volunteers. They have greatly contributed to all of the work of the church this year. With board meetings, committee meetings and lots of homework, they are the source of our achievements. I would also like to acknowledge all of the members and friends for their volunteer work for Emerson. I cannot begin to list you here, but without your passions and devotion, Emerson would be a very different place. Thank you. I would like to acknowledge too, the committee chairs, both those who have completed their terms and those who are continuing to serve.

The staff has been a joy to work with and provided good advice along with tremendous service. I especially want to thank Becky and Mark for their encouragement and wisdom as I needed, Karen and Molly for their efficient and timely reports and information, Bonnie, Anita and Bill for inspiration, and Efrain for his ever cheerful help.

## **Facility Usage**

Emerson UU continues to be the "home-away-from-home" for the Houston Feldenkrais Training Program The group will be training in Westwood Hall three times a year – May, September, and November – until their graduation in December 2013. Emerson hosted the 2011 Bioneers Conference November 11<sup>th</sup> and 12<sup>th</sup>.

Tanglewood Academy led by director, Glenda Lane, renewed their contract as did the Rebels Investors Group, Professionally Speaking Singles Toastmasters, and The Houston Tuesday Musical Group. Guitar Houston and UniTunes held their concerts at Emerson. Numerous neighborhood homeowners' associations held meetings in WWH.

Emerson itself a very busy community; some of its usage included monthly board meetings, board retreats, coordinating council meetings, PAC theater events, sustainable potluck and movie series, solstice celebrations, spring auction, teacher training, recurring committee meetings and numerous one-time events. ## 2011 Annual Report - Director of Music Bonnie Wellington

The year 2011 proved to be a diverse and productive one for the Performing Arts Department. Performances from each group within the organization set a new and higher standard than the year before, and the department as a whole is stronger than it has been in years. Musical performances from outside musicians along with collaborative performances within the department have made Emerson both more diverse and simultaneously more unified.

With the support of the congregation, we were able to bring onto the staff roster long time Emerson Intergenerational Orchestra Director, Bill Atkerson. Having supported the musical life at Emerson for over a decade, Bill has continued to develop the 'unique to Emerson' orchestra. Although the number of attendees in the spring was appearing to wane, this turned around in the fall. The number of participants is back up, and their performances this past fall proved to be some of the best sounds to have ever come out of the group; Bill's arrangement of *The Killer B's* (combination of music by Beethoven's Symphony No. 5, Brahms's Symphony No. 4 and Bach's Double Violin Concerto) was just fantastic and displayed a new level of musicianship within the orchestra.

The Worship Committee continues to support the Performing Arts at Emerson, and the 2011 Summer Worship Series proved to be a fantastic collaboration between the members of the Worship Committee and the Performing Arts Department leadership. The music performances during this period were appropriate to the services, and yet varied wildly in style and culture of origin. The goal was to have music during the summer months be just as present and as high a quality as during the normal Worship Season. Emerson instrumentalists, vocalists, and guest musicians including those versed in Indian Raga music stepped up to the plate, adding to the musical buffet last summer.

We said goodbye to two of our beloved section leads, Jessica Jones-McCann and Abigail Levis, and welcomed in two new talented staff singers, Ashley Neumann and Mary Brook Quarles. We welcomed back our Head Section Lead, Adrian Rodriguez who tirelessly takes on additional responsibilities, assisting the department in continual growth. Adrian was instrumental in wetting the musical pallet of the Religious Education Department, and helped take on mentoring Suoni Dolci. We have been tremendously blessed as a Department and as a Congregation to have such talented and dedicated lead singers.

The Emerson Players gave two stellar performances in 2011: *Love Letters* directed by Ken McLeod, and *Varney the Vampire*, directed by Hilary Henderson. Each of their performances this past year included members from multiple generations, with volunteers and staff alike participating. With each production one can see the attention to costume and

set design, and a deeper connection to the craft of acting. The Players also agreed to begin participating in Worship Services. Volunteers from the Players gave us their first ever 'performed prayer,' during Sunday Worship this past November. There was a time there that many weren't sure if the Players would be able to move forward after the tragic loss of the much beloved Emerson Players Founder, Don Whittaker. Not only have the players risen from the ashes and honored Don's memory, they have etched out and established their place here at Emerson, making them an invaluable part of the Department.

The Choir and Suoni Dolci continue to represent from the vocal side of the house. The Fall season began somewhat rocky for the Suoni Dolciers, with their long time leader Anita Butt taking a much needed break. However, with their eagerness to learn, and with Adrian Rodriguez agreeing to come on as their new mentor, Suoni Dolci continues to progress. They started the season by performing *Nine to Five*, having learned the song in a way they had never practiced before: by ear only!

The Choir gave beautiful performances over the past year including Wolfgang Amadeus Mozart's Vesperae solemnes de confessore, K.339, an all-time achievement for the choir, and A Holiday Review: Manger Danger, a home grown musical production that brought together numerous facets of the Performing Arts and Religious Education Departments, another all-time achievement. The working up of Mozart's Vespers was incredibly challenging. Musically and technically, it was one of the most difficult pieces the Choir had ever performed. It was a testament to their dedication and love for the art of musical worship. The Holiday Review was something so special; written by Emerson's own Andrew Hager, stage direction by Hilary Henderson, children's music directed by Adrian Rodriguez, RE music coordination from Katy Carpman, Emerson Players acting, fantastic solos from section leads, strong playing from previously known as Waldo band members and guest talent, the Choir singing and dancing, volunteer stage management, costume design, sleigh bells, donuts, lights, camera, action.....I think you get the idea that it was a lot to put together. But, what a wonderful display of the Emerson community coming together to make something wonderful, unique, and funny! And, we made it ourselves. We are learning to come together and share the load, and in the end, the load turns out to be uplifting. With Suoni Dolci, the Choir, and the other musical ensembles rotating performance responsibilities throughout the Worship calendar, they are each able to provide a higher level of performance, and subsequently are able to get more out of their performances themselves. The ministers continue to provide valuable guidance and trust in the performing members and Department Staff. Kevin Crotty and Xavier Keys volunteered to assist with their instrumental talents on a regular basis, adding yet another dimension to the musical landscape. Each and every single week of the year the Audio Visual team continues to plunge ahead and work with our funny patchwork AV system and board....they're in serious need of some extra volunteers by the way;) We are so very blessed to have such a talented and tireless group of volunteers and staff. Goals for the future: continue to share and integrate each facet of the Performing Arts Department on a more regular basis, allowing more visibility into the depth and varied talents of the organization.

#### **Vision and Mission Statements:**

**Vision:** Emersonians living their lives based on UU principles.

**Mission:** Provide intellectually and spiritually stimulating programs

supporting UU principles.

Chair retires: Ken Salzman, having served as committee chair for the Adult RE Committee for 6 years, declared in Jan. his intention to retire at the end of June, 2011. Mary Ann Stanley, a major contributor to the committee for the last 6 years, will retire from the majority of her functions at that time, continuing her contribution putting out the monthly Adult RE brochure of activities. She will also repeat her class on UU history in the fall.

**Adult RE Committee** continued our popular offering of 'classes' following a 'small group discussion' format on the 3rd Sunday of each month, labeled "Exploration Sunday". The dedicated leaders/facilitators of these groups are Ann May, Carolyn Truesdell (2 years each), Nancy Lipp, & Barbara Stoddard. Barbara Stoddard's class was canceled in Jan. due to lack of participation. Thank you for your valuable contribution to the Adult RE program. The 'Sunday morning Speaker's Series' continued apace.

The *MultiGenerational Class "Gather the Spirit"*, focusing on the critical function of *Water* in our lives continued in the spring, using a new UUA curriculum, and facilitated by Barbara Stoddard. This class was offered on the 2<sup>nd</sup> Sunday in place of an Adult RE program.

Once again, we were honored with a 2-part series by our own Laura Emerson, a generous contributor to the Adult RE program.

The Welcome MAT program, a monthly program showing movies dealing with various aspects of the GLBT life style, continued this year. Started as a demonstration of our commitment to our status as a Welcoming Church, it has drawn a

few outsiders into our facilities. Unfortunately, attendance has dropped off to the point where, at one session, the author was the only attendee. The format is being reviewed with the intent of dropping the movies, substituting 4 Adult RE sessions next church year.

The Adult RE presentation on the Adult OWL offering drew a limited response of interested adults. Kay Bergen and Ken McLeod were to lead the program but in the fall it was decided that interest was too limited for the evening time slots proposed and it was decided not to pursue the program until a larger class could be constituted.

Once again Judy Richardson stepped forward, and, with the able assistance of Phyllis Burchfiel and Pam Lewis (Dreamworks, '08-'09), has developed a 5 part series on Women at Midlife starting their monthly presentations on the 2<sup>nd</sup> Sunday, in Jan..., 2011. Taking pre-registrations in order to insure a manageable turn out, the course was rapidly oversubscribed, resulting in a waiting list for the next offering. When the course concluded in May, there was significant interest in it being repeated in the fall.

A report on the Adult RE aspects of the Leap of Faith program, a mutual mentoring program with the Cedar Lane church in Bethesda, MD, indicated the extensive activities included under Adult RE at their church which are handled separately at Emerson; i.e., circle dinners, covenant groups, continuing education classes (when LLU was still here), etc. This expansion was suggested as something worth exploring by Emerson's Adult RE Committee.

**New Committee Leadership:** The Adult RE Program began the new Church year in September with new leadership and a full slate of Adult programs through the year. Norbert Welk and Robin Sickles (co-chairs) took over for Ken Saltzman. It was only appropriate that it took two people to do the job that Ken had done so remarkable well for these many years.

The theme of presentations in the fall focused on church governance, the long term strategic planning of the church's resources, and how our beloved community can recognize and embrace diversity, beginning with diversity among our current members in regard to age and attendant concerns and values that may be age dependent.

Based on recommendations by the **Leap of Faith program** we continued the dialogue on how the many programs within Emerson that provide spiritual fellowship for its adult members may be viewed in a larger educational context.

We continued and add to the many of the spring programs as the grass roots efforts of our congregants to provide their own inspiration for programming continued with the "Explorations Sunday" on the third Sunday. A new group lead by Mary Ann Stanley utilized UUA educational materials to study UU history. The "Women at Mid-life" program continued to meet on the 2<sup>nd</sup> Sunday at the same time as our regularly programmed Sunday Adult RE. Mark Edmiston-Lange oversaw the Thursday evening six week program "Building Your Own Theology," which ran for two hours on six consecutive Thursdays (September 22-October 27) and attracted more than 20 people. The facilitators for this program were Kenneth Jones, Sally Phillips, Holly Gilliland, and James Dean.

In the fall Emerson changed its offering schedule for the Youth RE classes to coincide with the regular 11:00 service. Thus those adults with children who often may have come early to drop off their children and stay for the 10:00-10:45 ARE programs came instead directly to the services. ## 2011 Annual Report - Communications Committee Chair: Sherle Frost Watson

Several areas of interest received special focus during 2011.

#### 1. Social Media

- New Emerson website launched
- Facebook/Twitter Promotion
  - We're adding more Tweeters than Facebook Friends. Tweeters tend to be from outside Emerson and we're adding about two new ones per week; Facebook Friends are more likely to be Emersonians and we have over 300 followers.
  - o Emerson received recognition in February as one of the Best UU Congregational Tweets
  - o Six people attended Molly's RE class.
- The UUA Houston Network held a workshop for congregations on social media on March 5. Emerson attendees: Mark E-L, Molly, Pat, Sarah and Sherle. UUA has adopted the Emerson Social Media Policy (developed by Pat and Molly) as its model. Emerson is actually ahead in this area in many ways. We will keep in touch as this area grows.
- Periodically items were submitted to ultimatememorial.com, the online Chronicle site for our neighborhood, and they were mostly published but require repeated follow up.
- 2. Campaign of Gratitude experienced limited usage.
- **3. Leap of Faith** messaging added to website. Also, Molly created an excellent presentation for Mark's presentation in New Orleans at the Leap of Faith conference, which is now used on the screens in the Gathering Place.
- **4.** Our **CLVI licensing fee** does not cover all the movies we've been showing, ie First Fridays and Sustainability. Even if we do not publicize the movie outside the church, we are violating the law if we do not pay the fees. RE has amended their process. Coordinating Council members were advised that, if there is any question, movies can be vetted by Molly to ensure that they are being presented legally.
- 5. We started posting the weekly **Wayside Pulpit** message on the street using our currently available signage; one side has the sermon information and the other has the Wayside message matching the one in the Westwood Hall window that week.
- **6.** Following a healthy discussion on the 2012 budget we agreed to fund the activities that are specified in the addendum below.
  - The KUHF/KUHA ads funded jointly through the UUHouston network of churches are ending with 2011. First and Bay Area dropped out of the participating pool, so the cost for continuing became prohibitive. Additionally, the Communications Committee does not view our participation as an effective means of drawing people to Emerson. Therefore, our budget proposal included a variety of new initiatives (GL Yellow pages display ad, Facebook ads, mailers) that we need to test in order to determine if we get more out of them; we think we will but we have to spend the money to see. However, we will continue to work with the Metro Strategic Planning Group on possible joint efforts.
  - We are also dropping our ad in the regular Yellow pages.
  - We will be working closely with Membership to determine which of our initiative is effective in bringing in new members.

## 2011 Annual Report - Director of Religious Education (DRE) Search Committee Chair: Kimberly Coolidge

For the past two years, the Director of Religious Education (DRE) Search Committee and our Interim DRE, Barbara Stoddard, worked hard to attract and welcome our new Director of Religious Education, Katy Carpman, to Emerson. In January of this year, we conducted a mail-out campaign to members of the Liberal Religious Educations Association (LREDA), and posted the opening on our website and on the LREDA Employment Opportunities Homepage. Additionally, Mark, Becky, and Barbara Stoddard spread the word about our search at several professional conferences by sharing the *Are You Our Next Director of Religious Education?* tri-fold with interested parties. Subsequently, we received applications from all over the country.

In February, the committee generated an interview question list from our guide, *The Search for Religious Leadership: Best Practices for Unitarian Universalist Congregations* and additional input from Barbara Stoddard and the Religious Education Committee. We also reviewed the applications and narrowed the field to three candidates, all from different U.S. time zones, whom we interviewed by phone.

In March, the Search Committee took the next step by interviewing our top candidate, Katy Carpman, in person. After spending time with her over dinner and a full day of interviewing, we all were extremely impressed with Katy's professionalism and enthusiasm for the role of DRE at our church. Becky received glowing recommendations from Katy's references and everyone on the Search Committee agreed that Katy was exactly the right person we needed to lead our growing RE program. Representatives of the Search Committee made the official recommendation at the Board of Trustees meeting in March.

## 2011 Annual Report – Investment Committee Co-Chairs: Will Irwin and Dick Mullineaux

2011 marked a decision to make a major change for management of the Endowment Fund for the 3-year period from 2011 to 2014 when the mortgage on Delaney Hall must be refinanced. The Investment Committee has the dual responsibility for achieving above average returns on our investment and for being able to meet potential demands by the congregation for funds without endangering the long-term viability of the endowment fund itself.

This responsibility led to the decision to close all equity investments managed by the Mitchell Group while alternatives were evaluated. This decision was executed on March 5, 2011 and \$1,924,558 was transferred to the Charles Schwab EUUC Endowment account bringing the total of that account to \$2,030,000. After careful evaluation of options it was decided to invest \$1,000,000 in fixed income instruments for 3 years and place \$1,000,000 for equity investment in the energy industry managed by the Mitchell Group. The Mitchell Group were advised that the investment committee desired these funds not be invested in energy equities until such time as they considered it wise to do so.

The remaining cash is in the Charles Schwab Endowment Fund account to provide for possible requests for transfer to the operating account.

This short-term tactic will be reviewed at the end of the 3 year period to determine the future long term strategy.

## 2011 Annual Report – Lay Pastoral Ministry Team Chair: Dick Cheney

The Lay Pastoral Ministry Team ("LPMT") is a group of volunteers who provide a confidential Ministry of Presence to Emerson congregants and friends as an extension of, but not a substitute for, the pastoral care services of Co-Ministers Becky and Mark Edmiston-Lange. Lay Pastoral Ministry support is usually requested during times of life transition, such as illness, death of a loved one, marriage, divorce or separation, birth, loss of employment, retirement, or confinement to a nursing home. LPMT members develop confidential relationships that vary from a brief ministry of one or two phone conversations to visits sustained over many years.

Early in 2011 we welcomed three new members\* after they completed their extensive training program, along with four "trainees" from Northwoods Unitarian Universalist Church. Throughout the year, the Emerson team

- · Provided many hours of Ministry of Presence to many Emersonians;
- Continued the Joys, Sorrows, and Milestones candles and cards in the sanctuary. Every Sunday an LPMT
  member prepares the bowl to receive the tapers, extinguishes and removes the tapers after the service, and gathers
  any cards deposited in the two boxes. At our monthly meetings, we lift up the Joys, Sorrows, and Milestones that

are mentioned on the cards or otherwise known to us. Several of the cards also requested brief contacts for pastoral attention; and

• Delivered holiday poinsettias to a number of Emersonians with limited ability to travel.

Linda Orr moved out of Houston in mid-summer, and no longer serves on the team.\*\*

## 2011 Annual Report - Leap of Faith Team Chair: Linda Condit

Members: Mark Andersen, Sarah Boyd, Linda Condit (chair), Rev. Mark Edmiston-Lange, Holly Gilliland, Deborah Landis, Nancy Lipp, and Ben Withers.

Emerson was selected in 2010 to be one of eight churches poised for growth to participate in the Leap of Faith program. After attending the UUA's kick-off meeting in New Orleans, the team identified its challenge and expanded its membership. The challenge identified as being the key to growing our membership is "to make the UU faith more explicit in our congregation and in our daily lives." This challenge has inspired many of our recommendations.

Early in 2011 we were paired with our mentor church Cedar Lane UU Church in Bethesda, MD and their team members – David Devlin-Foltz, Nancy Janssen (chair), and Rev. Heather Janules. Many of our ideas were mined on our trip to visit Cedar Lane in March and from their visit to Emerson in May. Final recommendations and detailed reports on visits to both churches are on Emerson's Leap of Faith site.

#### **Major Recommendations**

The first is to adopt the Emerson AIMS to Grow model and its use by other committees in contexts such as Emerson AIMS to Serve. We *awaken* interest about Emerson in the greater Houston Community and *involve* those who come as visitors. Then we *motivate* prospective members into increased activity within Emerson and becoming members. Next we help members to *shine* the light of our faith in the congregation and the wider community.

The second recommendation is to update the church committee structure to have fewer standing committees, which would be umbrella organizations for various working committees and groups. This recommendation encompasses having committee charters and term limits for committee chairs as well as leadership development. The Coordinating Council will have a leading role in this effort.

The third major recommendation is to increase the paid staff with two part-time positions of a Membership Coordinator and a Religious Education Assistant over the next 3 to 5 years.

#### **Other Recommendations**

Our report contains numerous other ideas, which have been shared with various committees, and many have been put into practice. For example, we had two classes with six sessions of Building Your Own Theology. We think that a covenant group will result from this. We also have some faith statements to post on the website. Another example is the "Join Emerson Sunday" with the opportunity to sign the membership book. Also, the wayside pulpit (quotes on our sign in front) is a great way of being more explicit about our faith.

## **Communications and Implementation**

Communications are of key importance to this project. Team members are each assigned to a specific key committee and have been sharing info and getting input along the way. We have a Leap of Faith site on the Emerson website and have had articles in the newsletter as well as in e-blasts

We presented our report "Taking a Leap of Faith: Roadmap to Change" to the Board of Trustees in November and to the Coordinating Committee in December. Then on February 5<sup>th</sup>, we are slated to give a presentation at an Adult Ed session. Further communications are planned in the newsletters and e-blasts.

In April the Board approved our charter, and a key responsibility of our team is to assist with putting recommended programs and changes in place. Even though our team will be concluding its formal work in the first half of 2012, team members will continue to work with their assigned committees for the foreseeable future. Ultimately, the committees will be responsible for instituting changes in their areas of responsibility.

Conversations with our newest members indicate an overwhelmingly interest in growing their spirituality, and giving of their personal time and resources to serve liberal causes. The new members did not come here to sit in the pew, be entertained and send in money every week. The spiritual challenge of Becky and Mark's sermons and service opportunities at Emerson are exactly what our newest members are seeking.

This committee includes greeters who are on the committee, but prefer to only perform that invaluable function. This is particularly significant because the vision to maintain membership is to encourage involvement, but not burn out. Greeters can greet as little or as much as they are able and are also provide an excellent "entry level" involvement for new members.

The first major change was to implement "Join Emerson Sunday" once a month. This is done in the Library after church one Sunday a month and occasionally before the service at 10 am to accommodate parents with children. This new format provides an opportunity to explain what is expected of membership and makes it more intentional than simply completing a card. New member recognition continues twice a year during the Sunday service to publically recognize those who have joined in the last 6 months.

This past year also included incorporating many new ideas from Cedar Lane, our Leap of Faith partner. An important initiative for 2011 and continuing into 2012 is gathering specific information from visitors on how they found Emerson. ## 2011 Annual Report – Partner Church Committee Co-Chairs: Martha and deForest Ralph

Unitarianism, as a religion, was first articulated in the mid 1500's, in Transylvania, by Francis David. It was here that the name "Unitarianism" was first applied to our religion. After the fall of communism in 1989, UUs in North America were again able to contact, and support, the Unitarians in Transylvania and Central Europe. In 1993, the Partner Church Council (UUPCC) was formed as an affiliate of the UUA, to coordinate and enhance the support efforts.

The Partner Church Committee is Emerson's link to the UUPCC, as well as to our partner church in Transylvania, St. Nicholas. Through our association with the UUPCC, we participate in the support of UUs around the world, primarily in Central Europe, the Khasi Hills in India, and the Philippines. Our partner church, St. Nicholas, is located in the town of St. Nicholas, in the eastern part of Transylvania, which is now par of Romania. The people in that area are ethnic Hungarians. In Hungarian, the town is called Gyergyoszentmiklos, in Romanian, it is Gheorgheni. St. Nicholas has a congregation of about 125. Until November of 2008, it was the "daughter" church to the Unitarian church in the nearby larger city of Csikszereda. The Special Offering in April 2011, was for St. Nicholas.

Committee Co-Chair, deForest Ralph serves on the Board of the UUPCC. In February, he went to the Board meeting in San Mateo, California, and in June to the annual meeting of the UUPCC, held in conjunction with the UUA General Assembly, in Charlotte, North Carolina. DeForest also participated in monthly phone conference Board meetings. The UUPCC works with the UUA's International Office, and through it, it works with the International Council of Unitarians and Universalists (ICUU), which is the international organization for the national UU associations.

While in California, he visited Starr King, on of our UU seminaries and visited with the Balazs Scholar and his family. The daughter was in need of some surgery to correct a problem left over from surgery when she was a baby, and deForest was able to arrange for her to have the corrective surgery here in Houston at the Shriner's Hospital.

For 2012, the Committee plans to promote a trip to Transylvania this fall as part of the International Convocation of Unitarian Universalist Women that will be held in Transylvania in early October. Also, the Special Offering in February will be in support of the Balazs Scholar program, and the one in April will be in support of St. Nicholas.

- · Various groups performed in the sanctuary during the year, including the "Austin Troubadours" in April.

- UniTunes continued its policy of booking top acts to the church. Attendance has been steady with some acts drawing 200 or more but with most drawing in the neighborhood of 100.

## Religious Education Committee - Annual Report 2011 Submitted by: Kay Kamas

The Religious Education Committee is composed of seven members with Jill Shaffer, Florrie Snively, and Judy Williams serving their 1st year; Linda Daichman and Kay Kamas serving their 2nd year; and David Bergt and Faisal Nazir serving their 3rd and final year. Our Board liaison for 2011 has been Aaron Knight.

2011 has been a year of transition for the committee and for the R.E. Department. We said goodbye to Jay Jackson who served as Chair last year and did an absolutely exemplary job. We also said goodbye to our interim R.E. Director, Barbara Stoddard, this past summer and welcomed our new R.E. Director, Katy Carpman, in August. Katy very quickly proved herself to be extremely competent, personable, fun, bright, professional, organized, resourceful, etc, etc. It has been a joy for the committee to work with her and be guided by her professional and personal wisdom even as she was "getting up to speed" on life at Emerson. Regarding curriculum decisions, the committee focused on UU values in order to be consistent with the results of our congregational survey. We had an unexpected budget short-fall discovered after the summer, which was remedied by transferring unused DRE Search funds into the R.E. budget. And, we were fortunate to have Ben Withers as our Leap of Faith liaison - he provided us with valuable feedback regarding the religious education program being "a key element of sustained growth in our congregation." He shared with us what we were doing "right" and also recommendations for improvement in areas related to curriculum, use and care of volunteers, and over time, the benefit of increasing paid staff by adding an assistant DRE or someone dedicated to Coming of Age and YRUU.

Registration and attendance numbers have been strong this year. There are currently 143 children registered in the R.E. program (23 in the nursery & preschool, 55 in Kindergarten thru 5th grade, 28 in middle school, and 37 in YRUU). Average attendance for 11 AM Sunday School classes is 76, with an average of 41 at 10 AM (Multi-age, Coming of Age and Young Religious Unitarian Universalists). We also have an impressive squad of dedicated teachers, mentors, advisors, and other volunteers - an average of 31 people each week!

#### **Highlights of the year** include:

- **providing the OWL curriculum** for K/1st graders and 4th/5th graders beginning in January;
  - our youth along with other area youth hosting the Houston Youth Rally over MLK weekend at First Church;
    - partnering with the Social Action Committee in Souper Bowl of Caring
    - Cordelia Wilkes winning the Boniuk Center's religious tolerance essay contest
    - witnessing 14 of our middle school youth completing the **Coming of Age program** in May and participating in an **area-wide bridging ceremony**;
    - having a **volunteer appreciation lunch** in May, on the same day we had our first visit from Katy;
    - **providing the Dr. Seuss curriculum** for our summer R.E. classes,
    - having over 20 H.S. youths attend the July YRUU beach trip
    - YRUU continuing to meet over the summer, organized by Carla Hill;
    - successful teacher recruitment led by Linda Daichman;
    - a successful Homecoming & RE registration, facilitated by helpful, clear and concise brochures created by Katy;
    - a VERY successful Unicef Carnival, on Halloween, organized by Karen Nazir, Karen Benson, and Susan Green, which raised \$1,100 in addition to a generous Sunday plate collection:
    - a helpful Faith Development "Start-Up" Workshop on Nov. 5 facilitated by Jennifer

Nichols, District Director for Lifespan Faith Development, in order to clarify and support Katy's position as R.E. Director and to enhance our ability to work together to create dynamic programs;

- a wonderful holiday season with our **children participating in the Holiday Revue**, with Adrian Rodriguez directing their special children's song, and **staging a splendid Christmas Pageant**, Good King Wenceslas, directed by Hilary Henderson with choral assistance from Adrian Rodriguez. Also, **the Mittens (and more!) Tree provided warm clothing to Montrose Grace Place**, an organization that serves homeless GLBT youth.
- adding **children's nametags**, each with a symbol signifying the class curriculum.

Two ongoing challenges are: First, streamlining the drop-off and pick-up of our students for classes on Sunday morning. For example, since many of the parents are also teaching and must stay with their class until all are picked up, they are unable to pick up their own children in a timely manner. Various remedies have been tried and we continue to work with this process to maximize safety for all of the children who are in the pertinent age group (nursery thru 3rd grade). And second, finding a viable format for the 10 o'clock hour. To date, this hour has not been heavily attended, and because it serves a wide age span from Kindergarten thru middle school, choosing curriculum has been challenging. We also hear that many children prefer to have this hour as supervised free play/social time since they have a structured hour from 11:15 - 12:15. Currently, we have varied plans including a curriculum-based hour, rehearsal time for special programs, and supervised free play.

## Going forward this year, we will:

- plan our curriculum map for the next five years, since 2012 is the last year of the current map;
  - focus on recruitment, training, support and celebration of volunteers;
  - continue to improve our presence on the church website;
  - publish an RE Newsletter;
  - assess our space needs and make contingency plans for the future since our enrollment numbers are climbing.
  - look forward to increased collaboration between the R.E. program and many church committees as well as individual members.

We have a **committee retreat planned for January 21** where we will be addressing these and other relevant issues.

## 2011 Annual Report – Social Action Council Co Chairs: Christel Erickson-Collins & Phil Richardson

The vision of The Social Action Council (SAC) is A Church Community 1) where everyone is committed to service, within and beyond the Emerson Congregation, based on the seven principles and 2) where we are leaders in the Houston Community and share, individually and collectively, financial and time resources with organizations systematically and democratically chosen and sponsored by the congregation. SAC's mission and policies will be made available when SAC's website is updated. SAC is responsible for coordinating all of Emerson's Social Action projects and Endowment Grants. It also coordinates Special Collections and other fundraising for various charities and natural disasters. The Council meets every month and regularly educates the Congregation through the Emersonian and E-blast newsletters, a table in the Gathering Place, the Order of Service and SAC webpage.

Some of Emerson's 2011 Social Action projects were the following: **February SouperBowl of Caring**: 952 items and 1038 lbs of food and \$2,460 were contributed by Emersonians. Building and judging the food sculptures again was enjoyed by both our youth and adult members.

**Heifer International**: Coming of Age class members Alex Arabie and three others selected an ambitious service project. They collected more than \$6,000 over three months to purchase an Ark of animals for Heifer International to give to indigent farmers outside the USA.

**Groppe Scholarships:** A group of four members led by Sherle Watson has been tremendously busy supporting two students who are the first in their family to go to college. They raised funds, set criteria, sought applications and chose two students to sponsor. Funds were collected through private and special collections. The students now attend Houston Community College and are being tutored and supported by Emerson members who are part of Sherle's team.

April/May Social Action Survey: 112 Emersonians returned surveys which were made available in the Gathering Place and online for about four weeks. We appreciate your feedback and discussed your views during the June 12 Adult Education hour and June Emerson Board meeting. Emerson's diverse population completed the survey. 36% began attending Emerson since 2005 whereas 20% began attending before 1980. 47% came to Emerson from another denomination and 34% from another UU church whereas 19% had no prior church affiliation. Of that diverse population, only 2% think that we are doing too much social action but 32% want more social action. 94% with an opinion want us more recognized in Houston and told us how: 72% with an opinion said focus on fewer, large impact activities. The highest interest was in education and food projects with lowest interest in social advocacy. 27% replied that they already work on the SAC Committee or its projects with another 19% indicating an interest in participating in these activities. Although only 14% are against using any money from the operating budget for social action, 43% want to increase it from \$4,000 to \$10,000 per year or more. Similarly although 16% are against using the endowment for social action, 46% favor continuing the 10% Solution and 26% want to increase it with a higher % of the gain or a fixed % of the endowment balance.

**April and October Rebuild Together Houston:** This year Emerson again partnered with First Church and Northwest UU Church to renovate two homes for Houston's elderly. Teams of approximately 25-30 volunteers scraped, painted and repaired these home to the delight of their owners. The volunteers enjoyed working and visiting with each other and restoring homes for which their owners were pleased and proud.

**2011 Endowment Grants:** An Endowment Grant Evaluation Team comprised of Barb Adams, David Bates, Tony Collins, Will Irwin, Carolyn Truesdell and Phil Richardson was formed in September to solicit proposals from the congregation. It reviewed and evaluated the 13 Grant requests from the congregation and presented its recommendation to SAC on December 4. SAC approved the Evaluation Team's recommendation which was sent to and approved by the Emerson Board at its December 20 meeting. The Award recipients for the \$45,430 maximum Award will be voted on by the congregation at its January 22, 2012 Annual Meeting.

**Time and Talent Fair**: SAC manned a table at the Time and Talent Fair to enlist additional members for Emerson's social action projects.

**Pennies for Peace and ANSWER**: RE and SAC collaborated on this project to build schools in Afghanistan and Pakistan. While funds were being collected, the public was made aware of the fiscal irresponsibility of this program. Our project thus was discontinued and a decision was made jointly with RE to divert the donations to ANSWER, a program that sponsors education of children in Nepal. The aim of this organization is to move families upward in society through education and eventually to erode the harmful effects of the cast system.

**June Pride Parade**: On June 25 over ten Emersonians joined with members of other Houston UU churches to walk in the Pride Parade. This was a concrete way for Emerson to honor its commitment to being a Welcoming Congregation.

**Emerson Abolitionists:** This Fall Kay Kamas formed the Emerson Abolitionists to help combat the serious problem of human trafficking in Houston. Her group has met several times and has worked on a safe house for victimized women and girls and adopted a family for Christmas.

**November Self Watering Containers**: SAC and Emerson Ministry for Earth (EMFA) are collaborating on this pilot project initiated to provide Houston Food Bank clients with self-watering containers and vegetable plants to promote healthy eating and food sustainability. SAC funded the project through its operating budget funds. Construction has been

overseen by Zena Taylor, Christel Collins and EMFA. The initial project for 25 containers was expanded to over 50 due to savings and a generous donation. Construction began at the Bioneers Conference and will continue in March 2012 along with the planting. The Food Bank is partnering with Emerson to ensure appropriate distribution and follow-up evaluation.

Gordon Elementary School Science Project: A major effort this year was to build the science program at Gordon Elementary School, a Title I overflow school in southwest Houston. Bob Hopkins presented Science Boxes from the Houston Museum of Natural Science to the fourth grade classes every week or two. We also collected and distributed copies of National Geographic, Scientific American and Smithsonian magazines to each fourth grader. SAC helped expand the Gordon School Science Center for all grade levels with \$1,000 from its operating budget for science materials, such as an aquarium, live butterfly kit, rock and mineral collections, laboratory supplies and math teaching aids. Gay Gustafson contributed natural science teaching collections.

**International Scholarships**: Social Action Council sponsors three international students who go to school in India and Romania through the Hopkins Scholarship Program. This commitment was made by Emerson's on a multi-year basis. Another 12 students are being sponsored to attend school in Nepal through the ANSWER-Nepal program thanks to 11 generous Emerson members. None of these scholarships costs over \$300.

#### **Annual Report 2011 - Spring Gala and Auction Report**

Approximately 120 people attended, and 129 items were donated including 16 dinners or parties and 12 other events. The Auction Team hired Andrew Bost, a professional auctioneer from Austin and felt that his UU background and auction style was a good fit for Emerson. The evening began with the silent auction and safari themed food in the Gathering Place. As the Silent Auction closed, the guests were entertained outside by the KoumanKe'le African Dancers, and then entered Westwood Hall. In the future, the entertainment will be inside Westwood Hall to improve the timing of our auction evening.

The live auction was completed by 9 PM and the close out went well, as the receipts were ready by the time the door prizes were presented. Because of the need for a printer, the closeout was done in the volunteer workroom. Special thanks to Laurie Hammons and Sarah Hager for entering all the data on auction night.

A new item for Emerson was added to the live auction. It is called "Fund a Need" and guests were encouraged to bid on improving the accessibility in our sanctuary. This item raised \$12,250. #### Set Up Serving and Cleanup

Several volunteers (about 4 for food and 4 for beverages) helped with set up, serving and cleanup. There were two food tables, one large beverage table. Some food items were placed at available spaces on the silent auction tables and the beverage table( baskets of sliced cheeses and crackers and mixed nuts). This worked well. Meatballs were served hot in chafing dishes, one at each of the two food tables. All food was easy to pick up. For eating we provided picks, not forks. Serving tables were set up so that they could be accessed from all sides; this was helpful at the peak time when there were a lot of people circulating back and forth between the silent auction tables and food tables.

The set up included a staging area consisting of three tables and the counter in the welcoming area by the elevator with a screen to hide the staging tables. We kept extra fruit, sauce, etc. on the staging tables; volunteers replenished the trays as needed. Meatballs with sauce were kept warm in crock pots on the counter. This was accomplished with extension cords to the one outlet that is available in this area. Volunteers transferred meatballs from the crock pots to a bowl and carried them to the serving tables to replenish the chafing dishes as necessary. Next time we would have more wastebaskets and pay attention to placing them throughout the Gathering Place. Desserts and coffee were served in Westwood Hall and the beverage service was moved there for the live auction. The Gathering Place was cleared of food during the live auction. At the end of the evening, cleanup was greatly facilitated by our sexton. Our auction chairpersons arranged for him to work after the auction to take down tables, vacuum, empty the trash and prepare the Gathering Place and Westwood Hall for Sunday morning activities.

## Annual Report 2011 - Worship Committee Co Chairs: Carolyn Truesdell and Rachel Shada

As a standing committee at Emerson UU Church, the Worship Committee (WC) has two primary roles: providing worship services the twelve Sundays a year when the ministers are away from the pulpit and giving the "Welcome" at the beginning of each Sunday's worship service.

In 2011, the WC coordinated individual services in March, May, June, October, and November, and six consecutive services in July and August. This year the "last" service of the year coordinated by the committee fell on January 1, 2012 rather than the last Sunday of the December due to the Christmas holiday. The congregation was exceptionally positive about the WC's seven summer services which were inspired by our statement of purpose: "Our beloved community of Faith, Reason, and Affection welcomes all to grow in Mind and Spirit as we Build a Better World."

The committee members work diligently to include members of the committee and the larger congregation in the services we plan. However, to insure quality and variety in our services, we often seek outside speakers to whom we award an honorarium. In 2011, six of our services featured Emersonians as pulpit guests. The other six services highlighted visiting pulpit guests, including Alejandro Chaoul (MD Anderson), Earl Canfield (ANSWER), Bob Tucker (Center for Contemporary Theology), Mike Pardee (Boniuk Center), Jeff Kripal (Rice University Religious Studies Program), and Elliot Gershenson (Interfaith Ministries of Greater Houston).

The Committee is comprised of a small number of dedicated members: David Bates, Susan Raffle, Janet Meininger (our Board representative), and deForest Ralph, with Carolyn Truesdell and Rachel Shada serving as co-chairs. Ex-Officio members include our Music Director Bonnie Wellington – (who has been invaluable in coordinating music for the WC led services) and Mark Edmiston-Lange. Katy Carpman, Director of Religious Education, attends the meetings occasionally to coordinate activities with the children. Janet Meininger (our Board Rep) and Sarah Boyd (Board President) also went above and beyond this year and supported the WC by pitching in with our weekly Welcome.

As a point of consideration, the WC appreciates that this year's budgetary planning is even more difficult than most for the Board of Trustees. However, we are concerned by the second consecutive year of significant cuts to the Worship Committee budget. The Worship Committee depends on the money in our budget to award honoraria to our pulpit guests. Consistently cutting the available funds to do so will compromise our ability to offer the quality of services we provide that our fellow Emersonians have grown to appreciate. While we do our best to invite and include members in the services we plan, this is not always possible. Thus we feel it is imperative that our budget not be further cut. We do a lot with a little in the summer months and other Sundays when the ministers are away but are concerned that further reductions will adversely affect our efforts. We hope this will be considered in planning future budgets.

We are looking forward to another productive and successful year in 2012. In addition to planning our Summer Series, the WC hopes to identify ways to incorporate more lay participation in worship services and will continue to seek new members to join our merry tribe.
